Council Person, Lorraine Padavan of the Town of Vienna reported that she is hosting at the Town of Vienna an informational meeting with the Office of Aging on changes to Medicare on October 27<sup>th</sup> at 2:30 pm

#### **Resolutions:**

#### **Old Business:**

July 4<sup>th</sup> fire works the Mayor is requesting a temporary cancellation of the 4<sup>th</sup> of July fireworks for 1 year and then reevaluate at that time. He understands the pros and cons and not sure would be accomplishing anything. The Mayor believes it will not hurt the business community, the risk has evolved and waited for a full board as it comes down to safety and he would like to poll the board

The Mayor is also suggesting that the board think about private security he had received a quote from PIPSI out of Rome of \$35.00 per hour per man with 6 men and 1 supervisor total cost \$980 possibly 4 or 5 times during the summer. Also the possibility of increasing parking rate or time.

Trustee Daily asked if the security would be able to make arrest or will they need to be taken away from their post. The ratio of people to security waiting to be searched creating lines and hassle with social media will have an out flex. Not sure what is right way cannot depend on the NYSP & Sheriffs to be able to have enough force. Need to

make a change for next year to deter DJ from coming. Fireworks is key lean toward taking 1 year off and reevaluate for following year.

Trustee Shaughnessy start early going to get a ticket, ban coolers from beach

Trustee Clements the root of the problem is DJ on water petition only mentioned DJ not fireworks maybe we should have both Police and Security, there's got to be away to get DJ out feels we need to find out what the village can legally do

Trustee Sullivan asked who are the benefactors of fireworks, why do we have them, if businesses are closing because they can't handle the people this is a safety issue. Was not safe this past year Trustee Sullivan has no issues with BAN on fireworks for 1 year. Need police force presence. He is waiting for the committee that was formed to have a plan. Also feels DJ is a concern and need to do something.

Mayor Horan asked the board to be prepared to make their decision at the November 7<sup>th</sup> meeting on the fireworks.

#### **New Business:**

Village Spending / Sales Tax Revenue Mayor indicated that he, Joe Benedict and Wanda Durant had a conference call with County Legislator Norm Leach in that the Sales Tax recalculation by Executive Picente is back on the table and in full force Picente has developed a committee and we will know sometime around January 1. The Mayor would like to hold off on all major spending until we know, there are 4 items
