Parking, Tony Tennant provided the board with a recommendation on the striping and the traffic flow of the Sunset Park parking lot. Trustee Sullivan indicated that re-striping is a quick fix to some issues with parking and traffic flow that exist now and Tony did a

terrific job, Trustee Sullivan would like to get pricing for striping and layout. Mayor Horan asked if it would be unrealistic to have done by 4th of July. Joe Benedict was asked to get pricing and to see if this could be accomplished by the 4th of July.

Dump Truck – Joe Benedict presented the board with a couple of options for the need of a dump truck 1. Fix the 96 International at a cost of \$6861.36 2. Purchase 2013 International 6X4 for \$131,947 and 3. Purchase 2017 International 4x2 for \$114,814.00. Joe's recommendation is to fix the 96 and purchase the 2013. The Mayor suggested don't fix 96 and purchase the 2017. The Mayor polled the board and the consensus is to buy the 2013 the bigger of the two trucks

New Business:

Due to sales tax revenue being down by \$56,000 the A Fund will need a transfer in the amount of \$28,359.15 to cover expenses for 2015 and to close out the year. The CR Fund, Resort District, will end in a negative balance of \$8,569.27.

Motion was made by Trustee Shaughnessy and seconded by Trustee Sullivan to authorize the Village Clerk to transfer \$28,359.15 from the unassigned fund balance to the general fund to cover expenses for the end of 2015 fiscal year. Carried as follows
